AP® WORLD HISTORY LONG-ESSAY QUESTION UNIT 5: INDUSTRIALIZATION AND GLOBAL INTEGRATION

In your response you should do the following:

- **Contextualization:** Situate the argument by explaining the broader historical events, developments, or processes immediately relevant to the question.
- **Thesis:** Present a thesis that makes a historically defensible claim and responds to all parts of the question. The thesis must consist of one or more sentences located in one place, either in the introduction or the conclusion.
- **Identifying Specific Evidence:** Provide specific historical examples of evidence relevant to the topic of the prompt.
- Supporting the Argument with Evidence: Utilize specific examples of evidence to fully and effectively substantiate the stated thesis or a relevant argument.
- Using Historical Reasoning: Frame and structure an argument that addresses the prompt through historical reasoning (e.g., causation, comparison, continuity and change over time).
- **Argument Development:** Develop and support a cohesive argument that recognizes and accounts for historical complexity by explicitly illustrating relationships among historical evidence such as contradiction, corroboration, and/or qualification.

Question: Analyze cultural, political, and economic differences in the actual outcomes of the Berlin Conference of 1884-1885, to what could have transpired had African representatives conducted the proceedings.

Tips for writing the LEQ:

Question: Analyze cultural, political, and economic differences in the actual outcomes of the Berlin Conference of 1884-1885, to what could have transpired had African representatives conducted the proceedings.

LEQ structure:

- Be sure to include a Contextualization and Thesis statement(s) in your introduction. For THIS question, write 2-3 separate thesis statements (depending on your approach).
 - Option 1: Two sentences; summarize the cultural, political, and economic outcomes of the actual Berlin Conference in the first thesis sentence. For the second sentence, state your cultural, political, and economic suggestions.
 - Option 2: Three sentences; one for cultural, one for political, and one for economic. For each sentence, contrast the actual outcomes with your suggestions.
- For THIS question, you should break the essay down into 2-3 supporting (body) paragraphs (depending on your approach).
 - Option 1: present the actual outcomes of the Berlin Conference in body paragraph 1, followed by your suggestions if Africans had conducted their own conference in body paragraph 2.
 - Option 2: contrast the actual outcomes with your suggestions in three separate paragraphs; one for cultural, one for political, and one for economic.
 - o For either approach, include the ACTUAL Berlin Conference outcomes from BOTH the GENERAL effects AND the SPECIFIC effects (e.g., general economic = exploitation of Africans as cheap/slave labor, extraction of resources, use of Africans as markets for European goods; specific economic = King Leopold's use of the Congo Free State as his personal "piggy bank", reaping great benefits from rubber plantations, and resulting in terrible human rights abuses).
 - Be sure to also include what WOULD HAVE come of the Berlin Conference if Africans had conducted their own proceedings (e.g., economic = benefits of Africans utilizing their own resources, building up their own economies, etc.).

Possible body paragraph themes:

- Cultural language, religion, ethnicity, etc.
- Political actual kingdoms/states, rival groups, previous colonial holdings, etc.
- Economic natural resources, arable land, access to open water (minimal landlocked countries), relative population size, etc.
